The Common Council of the City of Park Falls met in regular session at 5:00 PM on Monday, November 29, 2021. Mayor Michael Bablick called the meeting to order at 5:00 PM and the following members were present:

# **COMMUNICATIONS**

Mayor Bablick thanked the Chamber of Commerce for successful events with Halloween and Christmas tree lighting He also introduced Tom LaVenture from the Price County Review. Alderman Bukachek thanked Ann Wojcieszak for donating the free movie that played on Small Business Saturday. Mayor Bablick also thanked Treml Tree Farm for donating the tree that was at Triangle Park.

#### **PUBLIC COMMENT**

Tom Ratzlaff thanked the mayor and the council for all of their hard work and time with the mill situation. Derek Chambers thanked the council for renovating the downtown but had a concern about the scale ramp in the alley by 3<sup>rd</sup> Avenue South, and also a house (421 3<sup>rd</sup> Avenue South) that could potentially result in an explosion because there is a gas main located on a building that is collapsing. Doug Leitl also expressed his concerns on this issue. Victor Ambrose informed the council that the school is now looking for a long term school superintendent.
